Privacy Policy for Springs Nutrition and Wellness

Introduction

At Springs Nutrition and Wellness ("we," "us," or "our"), we are committed to protecting the privacy and security of our patients' personal and health information. This Privacy Policy explains how we collect, use, disclose, and protect your information in compliance with the Health Insurance Portability and Accountability Act (HIPAA), the Cellular Telecommunications Industry Association (CTIA) Privacy Guidelines, and applicable state-specific privacy laws, including the Colorado Privacy Act (CPA).

1. Information We Collect

We collect various types of information to provide healthcare services and ensure compliance with healthcare regulations. This includes:

- **Protected Health Information (PHI)**: Information about your health, treatment history, medical conditions, and other identifiers necessary to provide healthcare.

3. Disclosure of Your Information

We may disclose your information to the following parties, consistent with HIPAA, CTIA guidelines, and state law requirements:

- **Healthcare Providers**: For continuity of care, including doctors, nurses, and specialists involved in your treatment.
- Insurance Companies: To process claims, verify coverage, and coordinate payments.
- **Business Associates**: Third-party vendors and partners that assist with services like billing, IT support, and data processing, under strict confidentiality agreements.
- **Legal and Regulatory Authorities**: When required by law, we may disclose information in response to court orders, subpoenas, or legal processes.
- Authorized Family Members and Caregivers: With your consent or as allowed by law, to assist in your care.

4. Your Rights and Choices

As a resident of Colorado, you have specific rights under the Colorado Privacy Act (CPA), in addition to HIPAA rights:

- **Right to Access**: You may request to see or receive a copy of your health records and personal information.
- **Right to Amend**: You have the right to request amendments to inaccurate or incomplete information.
- **Right to Restrict Disclosures**: You may request restrictions on certain disclosures of your information, such as for payment or treatment purposes.
- **Right to Deletion**: Under CPA, you may request the deletion of personal information, although some health information may need to be retained to comply with healthcare regulations.
- **Right to Opt-Out**: You can opt out of certain uses of your data, including targeted marketing (if applicable).
- **Right to Data Portability**: You can request your data in a portable format to transfer it to another provider.

5. Security Measures

We implement administrative, technical, and physical safeguards to protect your information from unauthorized access, disclosure, and misuse, including encryption, access controls, and secure storage. While we work to safeguard your information, no security measures can guarantee absolute protection.

6. Data Retention

We retain your information only as long as necessary to fulfill the purposes outlined in this policy or as required by law. Medical records are maintained in compliance with HIPAA and relevant healthcare regulations.

7. Children's Privacy

Our services are intended for adult patients, but we may collect information about minors with parental or guardian consent in compliance with HIPAA and applicable state laws.

8. Changes to This Privacy Policy

We may update this Privacy Policy to reflect changes in our practices or legal requirements. Updates will be posted here, and we will notify you of significant changes as required by law.
